AND WHEREAS it is deemed necessary to reduce the objectives and other terms and conditions of the trust into writing as follows:



- j. To start all other types of humanitarian service centers.
 - k. To maintain, organise, run, manage, supervise, superintendent, co-ordinate, affiliate, control, guide and aid Patasalas, Schools, Colleges, Hostels, Boarding Houses, Museums, Liberators, Exhibitions, Libraries, Lecture Halls, Practical and Training Classes and other education institutions.
 - l. To provide facilities for giving residential accommodation and boarding houses for teachers, staff and other persons engaged in carrying out any of the objectives of the trust.
 - m. To conduct camps, seminars, symposiums on various important topics, like health (STD/HW/AIDS). Pollution of Air, water and soil. Environmental issues early childhood disabilities, detection and prevention of childhood disease and all the related subjects.
 - n. To improve the health of women and children by introducing local health traditions.


Any of the above objectives will not be maintained and administrated for the purpose of profit.

shall be the first trustees and shall hold office for their respective lives and until ceases to be the trustee for any following reasons.


- a. He/She is found to be of unsound mind by a court of competent jurisdiction.
 - b. He/She resigns his office as a trustee.
 - c. He/She is expelled by the Managing Trustee.
5. The powers of the Managing Trustee are as under:
- a. The Managing Trustee shall hold the properties of the Trust for the objectives stated hereinafter.
 - b. The Managing Trustee is entitled to open bank account or accounts in the name of the trust and the Managing Trustee is empowered to operate the account.


- c. The Managing Trustee is entitled to borrow monies for the purpose of trust with or without security from banks, financial institutions or others and also have the power to effect any movable, immovable property or other funds of the trust as security.
 - d. The Managing Trustee is entitled to appoint personnel for the purpose of the trust for carrying out the objectives of the trust and also fix the terms of employment and to dismiss or dispense with services of such personnel.
 - e. The Managing Trustee is entitled to appoint Chartered Accountants, Legal Advisors and such other professionals on such terms as the Managing Trustee deem fit from time to time.
 - f. The Managing Trustee is entitled to file suits on behalf of the trust and likewise defend any action taken against the trust and also compromise and compound such cases.
 - g. The Managing Trustee shall have the power to acquire capital assets for the purpose of the trust and likewise the power to dispose them off.
 - h. The Managing Trustee is authorised to sell, lease, mortgage, or otherwise deal with any of the properties of the trust both movable and immovable as may be found convenient from time to time.
 - i. The Managing Trustee is authorised to invest the funds of the trust in accordance with provisions of section 13(I) (d) read with section 11(5) of the Income Tax Act, 1961 and rules made thereunder from time to time.
 - j. The Managing Trustee shall not carry on any business for the trust with the funds of the trust other than a business which is permitted under the provisions of the Income Tax Act, 1961 nor would any of the funds or income of the trust inconsistent with section 13(2) of the Income Tax Act, 1961 or other persons with section 13 of the Income Tax Act, 1961 so as to directly or indirectly benefit such persons referred to in section 13 of the Income Tax Act, 1961.
 - k. The Managing Trustee has the power to select appoint or co-opt by unanimous resolutions additional trustees to the Managing Trustee from time to time. They may have register of members where they may enroll members and can constitute committee also from the members of Register of members. The admission or expulsion of member can be made by the Managing Trustee at his discretion.
 - l. The Managing Trustee has the power to expel any trustee from the trust if they are against the objectives of the trust.
- 6. The Trustees are authorised to frame rules for the proper conduct of the trust and administration of the trust.
 - 7. The Trustees are authorised to collect any fees for carrying out the objects of the trust but such collections shall be only to meet the actual expenses without any element of profit.
 - 8. The trust is irrevocable and no part of the funds of the trust or income of the trust shall be taken directly or indirectly for the benefit of the trustees.





9. The Trustees shall maintain proper accounts of the trust on an annual basis and the same shall be audited by a Chartered Accountant.
10. It is hereby declared that any amendment to this trust shall be carried out only with the prior approval of the Commissioner of Income Tax having jurisdiction of the Trust.
11. It is declared for the removal of doubts that the objectives of the trust are not for the benefits of any particular religion, community, caste or creed.
12. If, for any reason, the objectives of the trust could not be achieved or for any other reason thought fit by the Trustees, the assets and liabilities of the trust may be amalgamated with any other trust, charitable society or institution having similar objectives and which is enjoying the permission under section 80G of the Income Tax Act, 1961.
13. It is hereby declared that for the removal of doubts that no activities of this trust shall be carried out outside India.
14. There will be no powers to effect amendments to the trust deed to the trustees / office bearers to alter the basic characters / objects of the Trust.


